

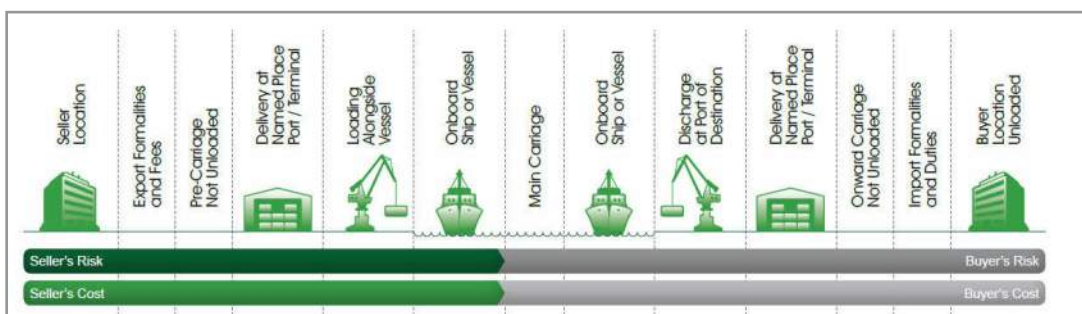

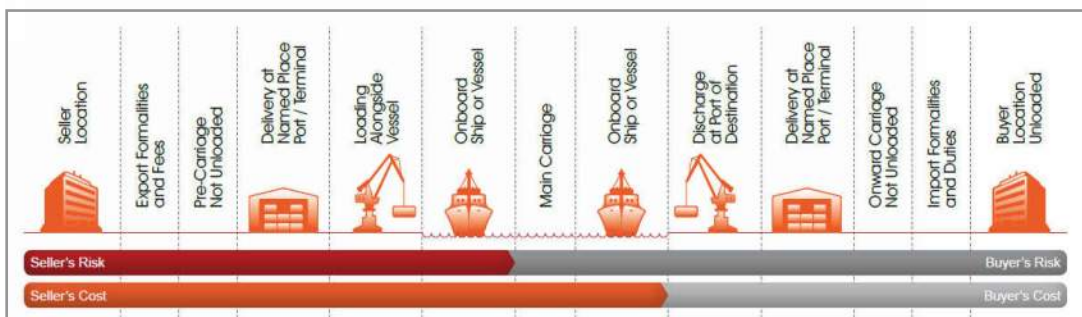

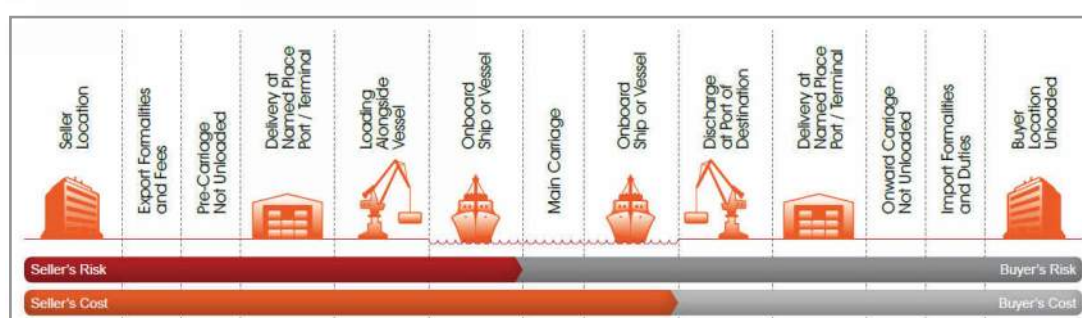
F.O.B. Origin Freight Collect: means that the title passes to the buyer at the port of origin, and that the buyer must pay the freight and insurance charges. The buyer owns the goods in the transit, and files all claims against the carrier. Purchaser will be billed directly by the carrier.



C.I.F. Cost, Insurance and Freight: means that the seller delivers the goods, cleared for export, onboard the vessel at the port of shipment, pays for the transport of the goods to the port of destination, and also obtains and pays for minimum insurance coverage on the goods through their journey to the named port of destination. The buyer assumes all risk once the goods are on board the vessel for the main carriage; however, they don't take on any costs until the freight arrives at the named port of destination.



C.F.R. Cost and Freight: means that the seller is required to clear the goods for export, deliver them onboard the ship at the port of departure, and pay for transport of the goods to the named port of destination. The risk passes from seller to buyer when the seller delivers the goods onboard the ship. The buyer is responsible for paying all additional transport costs from the port of destination, including import clearance and duties.

SHIPMENT AND DELIVERY

1. Port of Origin : Owendo Port, Libreville, Gabon
2. Type of delivery: One time / Contract
3. Trans shipment allowed
4. The buyer must consider any delays due to unforeseen conditions (rain days, etc).

PAYMENT

1. The payment shall be made in USD or EURO
2. After signing the contract, the buyer will pay 50% of the total amount. Balance 50% will be paid only after getting the Original documents. (Optional). We also allow Payment against Original Documents (Original BL)
3. Original Documents required are as follows,
 - 3 Original BLs & 3 Copy from liner
 - 3 Original Invoices by Woodsons Industry (Seller)
 - 3 Packing List
 - 2 Certificate of Origin
 - 2 Phyto Certificate.
4. It is the buyer's responsibility to arrange accordingly with Bank delays for processing the payment. (Usually 1-15 business days).
5. CASH IS ACCEPTED as alternative payment to avoid delays if in person.
6. Cryptocurrencies such as Ripple (XRP), Ethereum (ETH), and Bitcoins (BTC) are accepted for faster/ instant payments.
7. The seller can only confirm the receipt of the payment after the money is cleared and confirmed in the seller's Bank account or Virtual wallet (For cryptocurrencies)
